Unfinished Business

A. Town and Village of Parish Comprehensive Plan

Matt Johnson was present to discuss the Town and Village of Parish Comprehensive Plan. Mr. Johnson stated that changes were made based on the county's recommendations. He has been able to incorporate about 75% of the county's suggestions. The Board discussed the changes proposed by Bob Chambers. The Board agreed that all of the changes listed should be included in the plan. Mr. Johnson will include these changes and add paragraphs on the buildings in that section of the plan. Mr. Johnson stated that the process is to send the completed plan to the Town and Village Boards for approval. Once a 239-M is completed, the plan is

sent to Oswego County for approval. A public hearing would have to be held prior to adoption. A motion was made by Kevin Dwyer to approve the revised Comprehensive Plan and send it on to the Town and Village Boards for approval. Clara Sterio seconded the motion. A roll call vote was held:

Motion carried. Matt Johnson will make the revisions to the Plan and forward it on to the Town and Village Boards.

B. Village Zoning Law

It was recommended that a special meeting be held at 6 pm on October 25th to discuss the Village Zoning Law. Matt Johnson will bring copies of the new draft.
