NEW BUSINESS:

Motion to override the Tax Cap Levy: A motion was made by Supervisor Stelmashuck, seconded by Councilor G.R. Horning to pass Local Law #2 of 2016 authorizing the Town Board to override the Tax Cap Levy of 0.68% for 2016. Roll taken...motion carried.

Budget Public Hearing: A motion was made by Supervisor Stelmashuck, seconded by Councilor G.R. Horning to schedule a Public Hearing on November 9th, 2016 at 6:30 p.m. to hear all comments and concerns on the 2017 Preliminary Budget, and contracts for McFee Ambulance, and Parish Fire Company. Roll taken...motion carried.

Special Meeting: A motion was made by Supervisor Stelmashuck, seconded by Councilor G.R. Horning to hold a Special Meeting on November 9th, 2016 immediately after the Public Hearing to consider adoption or amendment of the 2017 Preliminary Budget, the Ambulance, Fire Contracts, and any other business to be brought before the Board. Roll taken...motion carried.

Paul Baxter stated that he would post the Public Hearing and Special Meeting for November 9th, 2016 on the Town's Website.

MEETING OPEN TO THE PUBLIC:

Bernie Horning stated that he had attended the informational Water Meeting and the speaker had stated that some septic systems are running into wells.

Supervisor Stelmashuck stated that he said was not aware of that situation happening but it would be the homeowners responsibility to correct the problem if it exists. Dale Chapman stated that he thought the Water and Gas Meeting was poorly organized. Dale Chapman suggested that the Town Board communicate with the school regarding the Water Project. The school has a long term planning committee.
