**Communications**

- Town & Topics were given to the Board members .
- Paul Gage read an email sent to Bill Scriber from a property owner on a new construction, no address given, questioning what can be done as there has been no Code Officer available to speak with. Bill Scriber responded explaining what the Planning Board deals with which are land issues and that the Zoning Officer is the enforcement officer of the Town Zoning law in the Town.

**Report of Committee**

- Paul Baxter stated as far as training sessions there are none scheduled at this time. He also informed the Board that he was at a Tug Hill staff meeting recently and the announcement for next year's Conference may come out a bit sooner than usual to make it easier to pace out the work with the office staff. Bill Scriber commented that they have been going smoother each year. Paul Baxter stated they are also looking at basis to responses to the survey given at the 2016 Conference, and they are seriously looking at possibly doing the conference in early June or late May in 2018. The 2017 is still locked in for late March because of the fiscal year end.
- Codes – The Codes Officer was not in attendance.
- Jen Reeher – The State Arbor Day is looking for original art work for the Arbor Day poster. They will be accepting submissions until the end of December.

- Bill Scriber stated it was in agreement to have the Planning Board meetings start at 6:30pm instead of 7:00pm. This change will take place starting at the November 28, 2016 meeting.
