REGULAR MEETING January 21, 2021

Audit Letter:

Discussion was held regarding Benn & Company. Councilor Dunham explained that this company will go through each department's books to get them prepared for an audit. Hiring an auditor was discussed and decided that it could be placed on the April Agenda. Councilor Dunham suggested that the Board set up a Zoom Meeting so the company could explain what they would do. No one was opposed to having Benn and Company attend a Zoom Meeting to discuss what services they could provide.

Employee Retirement Systems Forms: The ERS Forms that were previously discussed were not needed at this time as the employee has retried. The employee is just waiting on an adjustment form.
