Supervisor Bernys said he and Deputy Wood attended the SRCG meeting that was held jointly with NorCOG at the Tailwater Lodge in Albion on July 8, 2022.

Supervisor Bernys said he attended the Shared Services meeting at CITI in Mexico on July 8, 2022. A major topic was Broadband.

Supervisor Bernys thanked Bookkeeper Engst for doing a great job with the accounting.

Supervisor Bernys said he and Bookkeeper Engst met with Laird Petrie, formerly of the Comptroller's Office.

Supervisor Bernys said he and Bookkeeper Engst did a Webinar on Budget Navigation.

The Supervisor expressed his and the Town Board's condolences to Dog Control Officer Steve Cronk on the death of his wife.

Supervisor Bernys thanked the Parish Public Library for asking him to be the Judge of the sidewalk chalk competition. He said there was a lot of fine artwork.

Supervisor Bernys expressed his congratulations to Town Clerk, Kelly Reader and former Highway Superintendent Craig Petit on their upcoming nuptials.

Councilor Wood thanked the Supervisor for taking him to the SRCG/NorCOG meeting. He said it was very informative.

APPROVAL OF MINUTES:

June, 16, 2022 regular monthly minutes: A motion was made by Councilor Eaton-Novak, seconded by Councilor Wood to approve the minutes of the 6/16/22 Regular Monthly Meeting as received. Roll taken...All in Favor...motion carried.

EXECUTIVE SESSION: A motion was made by Councilor Wood, seconded by Councilor Eaton-Novak to enter into Executive Session at 6:06 pm to discuss the resignation and appointment of personnel. Roll taken...All in Favor...motion carried.

A motion was made by Councilor Houghton, seconded by Councilor eaton-Novak to adjourn from Executive Session at 6:26 pm. Roll taken...All in Favor...motion carried.

A motion was made by Councilor Eaton-Novak, seconded by Councilor Wood to enter back into the Regular Meeting at 6:27 pm. Roll taken...All in Favor...motion carried.

Justice Position: Councilor Wood made a motion which was seconded by Councilor Eaton-Novak, pending legalities, to appoint Devon Conroy to take over the position of Town Justice from Hon. Carl Dayger on September 1, 2022. Poll vote taken. Councilor Wood-Aye; Councilor Houghton-Aye; Supervisor Bernys-Aye; Councilor Horning-Aye; Councilor Eaton-Novak-Aye. All in Favor...motion carried.

McFee Ambulance Presentation 2023: McFee Ambulance members Johnson & Solazzo presented their new budget to the Board. They would like \$32,000 from the Town this year. Supervisor Bernys asked how much it was last year; it was \$27,578.25. The Board asked for statistics, so they will be back at the August Reg. Board Meting to present and answer questions.

DEPARTMENT REPORTS:

Assessor's Report: None.

CEO/ZEO Report: CEO/ZEO Hamacher read the CEO/ZEO written report.

DCO Report: Due to the death of the DCO's wife, he gave the Board a written report.

Fire Company Report: Chief Harvey handed out his report and went over it.

Highway Reports:

Hwy Sup't Horning gave the Highway Report. Supt. Horning said he turned down the bids that came in for the equipment we had for auction. He thought they were too low. Sup't Horning said the 2009 pick-up truck has 175,000 miles on it and is in need of \$5000 in repairs. He said the 2017 Ford F150 has 90,000 miles on it. He said the Case Loader needs tires which will run \$2,500-\$2,800. Sup't Horning said maybe we could sell the 2009 truck and put the F150 in its place and maybe lease a newer one for the Sup't. Sup't Horning said he would like to change the 284 agreement which would give him power to make some purchases on his own if he had to get something without contacting the Board. The Board discussed it and said they will decide at next month's meeting.

TUG HILL REPORT:

Paul Baxter, Tug Hill Rep. gave the following report:

Paul attended the first (SRCG) meeting of 2022 was held on Thurs. July 8, 2022 at Tailwater Lodge in Albion. It was held jointly with the North Shore Council of governments (NorCOG). Dave Turner, Director of Planning and Community Development and director of Strategic Initiatives and Ellen Holst, President of Board of Directors of Operation Oswego County, the County's Industrial Development Agency. Turner and Host attended to speak on the County's efforts and what could be done on the town, Village and sub regional basis. There was a consensus to continue with joint meetings between Nor COG and The Salmon Rivers Council of Governments in a format similar to tonight's meeting. The next is meeting is scheduled for Fall 2021, sometime between late September and early November. Paul thanked Sup. Bernys and Deputy Wood for attending the meeting and representing Parish.

Paul said he attended the Shared Services Meeting on Thurs. June 23 at CITI in Mexico, N. Y.. A major topic was Broadband.

Paul said the U. S. Dept. of Agriculture Rural Development held a webinar on July 13, 2022 on a grant program "to help provide planning support, technical assistance and training to foster place-making Paul activities in rural communities". Up to \$4 million is available for these grants. The deadline is August 15. If interested, more info & sign-up is available at www.tinyurl.com/USDARuralInnovation.

Paul said Harbor Fest is back for 2022 and he has a limited number of cards with Harbor Fest info.

Paul said he has started transitioning people to the new computers.

Paul added that Tug Hill had nothing new on the Wildlife Management Area.

COMMITTEE REPORTS:

ARPA-Highway Garage Repairs: We get 2 -\$103,000 checks for our ARPA Fund. Councilor Eaton-Novak asked what Highway Sup't Horning thought was the most dire item at the highway garage for the use of funds and he said the roof. He also said the i-beams needed replacing. Councilor Houghton disagreed and said he would look at them. He also mentioned a new furnace.

ARPA-Merrill Park: Councilor Eaton-Novak said she and Jack Rucynski and Gary Wood met at Merrill Park. Shelly Clark was supposed to come but was absent. They discussed areas for the ARPA funds such as: re-doing the restrooms, change to LED lighting, get ball field lights, resurface the tennis court, buy some steel cookers, get some soccer goals. We are trying for a \$30,000 repaving grant for the tennis court. The Board also discussed a permanent Community Christmas tree. We have one in Veteran's Park already. The Board said security and lighting is number one on the list. Sup. Bernys

said our electricity budget for the year is \$800. We have used \$187.98. Councilor Eaton-Novak said her and Mr. Rucynski will count the number of lights. Councilor Wood said he thinks we should have the electricity on there year round.

Councilor Wood made a motion to keep the electricity turned on year round at Merrill Park which was seconded by Councilor Eaton-Novak. Poll vote taken. Councilor Wood-Aye
