# **COUNCILOR'S COMMENTS:**

**Highway Report:** Hwy Sup't Horning was present and gave the Highway Report. There is also an upcoming class for highway superintendents and Nate has signed up for it

# **Tug Hill Circuit Rider's Report:**

On Wednesday, December 6<sup>th</sup>, 2023, there was a newly elected officials training session sponsored by the Tug Hill Commission, the Association of Towns of the State NY, and the Councils of Gov't in the Tug Hill region. There is also an upcoming workshop on highway department operations, which Paul has referred to the supervisor to forward to the incumbent highway superintendent of highways. The Tug Hill Commission has met Monday, Dec 11, and established its 2024 Meeting Schedule. The commission meets nine times a year and moves its meetings through the region to make its meetings more accessible to the local officials and residents of the Tug Hill Region.

They conduct meetings within each Councilor of Governments area and rotate that location every year. The commission has scheduled the 2024 meeting in the Salmon Rivers Councilor of Governments area at its newest member, the village of Pulaski, on Monday, March 18<sup>th</sup> at 10:00 am. As we get closer to March, Paul will mention it again. These meetings are open to local officials and interested area citizens.

In response to input from the town and village attorneys, the Tug Hill Commission has prepared an updated Memo of Understanding (MOU) regarding the former Key Bank, which has subsequently been circulated with the town, the village, and historical society. There is nothing new to report on salmon restoration for the Little Salmon River. Paul has presented the bill for the annual dues for NorCOG membership for calendar year 2023. # **Fire Department Contract:**

Supervisor Bernys has received the Fire Contract and he wanted the town attorney to review it and then he will sign it prior to the end of the year.

# **Highway Purchase Cap Amount:**

**Motion:** A motion was made by Supervisor Bernys, seconded by Councilor Houghton to increase the Highway Superintendent spending cap from \$2,000-\$4,000 to allow the Highway Sup't to spend up to \$4,000.00 without permission. Roll taken...All in favor...Motion carried. Aye-(4) Nay-(0).

# **Historical Society MOU:**

Supervisor Bernys commented that he signed the MOU as agreed upon by the Board. The town is working with the Historical Society to get them moved into the bank. It was discussed that the building will provide office space for the historian and the town will pay \$2,500.00 per year. The money would be given to the village for rent..

Motion: A motion was made by Supervisor Bernys, seconded by Councilor Horning to pay the village \$2,500.00 per year for rent for office space to the Historian's office. Roll taken...All in favor...Motion carried. Aye-(4) Nay-(0).
